# YOUR WEDDING STORY BOOK

## Terms & Conditions

It is agreed that the following terms of agreement form an integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by both Your Wedding Story Book Limited and the client, in writing.

**Booking Fee:** A non-refundable booking fee £100 is required at the time of booking, together with a signed contract. Please make cheques payable to Your Wedding Story Book Limited. Fees may also be paid online with Paypal to [gillian@yourweddingstorybook.com](mailto:gillian@yourweddingstorybook.com).

**Payment of Balance:** The sum of 50% of the balance due is to be paid before the interviews take place. The final balance is to be paid after Your Wedding Story Book Limited has completed the book and the client has read the digital copy and sent confirmation by email to print the book. The book will be printed when the payment balance has cleared. Further copies can be ordered within six months of the original order being printed at the then current price.

**Photographer's copyright:** It is the client's responsibility to obtain a written consent from their official wedding photographer to reproduce their photographs in a book published by Your Wedding Story Book Limited.

Copyright in book: All copyright and other intellectual property rights in the book remain the property of Your Wedding Story Book Limited at all times.

**Creative Licence:** The client will provide a high-resolution disk of the images of their wedding to be used in the book, together with a list of up to 200 favoured photographs. Your Wedding Story Book Limited will choose at their absolute discretion the pictures and words created in the layouts of the book. Reasonable amendments will be accepted **twice** after a digital version of the book has been sent to the client and before it is printed. Further amendments may incur extra costs at the current rate.

**Liability and Force Majeure:** Your Wedding Story Book Limited shall have no liability to the client for any loss, costs, expenses or any other claims if any information or instructions supplied by the client are incomplete, incorrect, inaccurate or in the wrong form or any information or instructions are late or not given when required or any other fault of the client.

Except in respect of death or personal injury caused by Your Wedding Story Book Limited's negligence, Your Wedding Story Book Limited shall not be liable to the client by reason of any representation (unless fraudulent) or any implied warranty condition or other term or any duty at common law, for any loss of profit or any indirect special or consequential loss, damage, costs, expenses or other claims (howsoever caused) which arises out of or in connection with the provision of the book. If Your Wedding Story Book Limited are proven to be liable their entire liability under or in connection with this contract shall be limited to a full refund of all monies paid.

Your Wedding Story Book Limited shall not be liable to the client or be deemed to be in breach of this contract if it is unable to provide the book by reason of any delay in performing or any failure to perform being due to any cause beyond Your Wedding Story Book Limited's reasonable control. In the event of cancellation of this contract by Your Wedding Story Book Limited, due to any illness or injury beyond their control, liability shall be limited to a full refund of all monies paid.

**Cancellation:** Should the client wish to cancel this contract at any time, notice must be given in writing to Your Wedding Story Book. The following sums will be due: notice given after the interviews, 50% of the balance due. Notice given after the book has been completed and before it has been printed, the whole balance of the sum due will be payable.

**Jurisdiction and Interpretation:** This contract is subject to English Law and the exclusive jurisdiction of English Courts. If any of these terms is found to be invalid under applicable statute or rule of law, then the provision shall be severed from this contract and the rest of the terms shall remain in force and effect.

**General:** A failure to exercise or delay in exercising a right or remedy under this contract shall not constitute a waiver of that right or any other right or remedy and a waiver of a breach does not constitute a waiver of any other breach of these terms.

A person who is not a party to this contract has no right under the Contract (Rights of Third Parties) Act 1999 to rely upon or enforce any term of this Agreement. This does not affect any right or remedy of a third party which exists or is available apart from that Act.

These terms and the documents referred to in it, constitute the entire agreement and understanding of the parties and supersedes any previous agreement between them.
